Why did we create this handbook?




Ukraine has a great potential in this area, which is yet to be implemented.





Breakdown of the world pharmaceutical market SALES in 2016*, %




Regional breakdown of the gross value added in the pharmaceutical industry, %






The world's biggest companies by revenue, bln US dollars


Ranking of industrial sectors by overall sector R&D intensity in 2015*, % (R&D as percentage of net sales)



On average, one drug development process lasts for 12-13 years and costs more than \$2,5 bln.

In order to stimulate an investment, the manufacturer gets a patent, which ensures an exclusive right to production and sales. In the USA, as well as in Ukraine, the term of the patent is 20 years.


Number of new drugs approved by US Food and Drugs Administration, pieces









Compound annual growth rate of capital investment in 2010–2017, %



Capital investment in pharmaceutical manufacturing industry, mln hryvnias






Financing structure of clinical trials in Ukraine*, %



Clinical trials provide an advantage for both the state and a patient. The patient gets free healthcare services and innovative medicines. While the state does not pay for seriously ill patients treatment. In addition, clinical trials are also an opportunity for further drug registration without supplementary research and investment in medical facility infrastructure.

The low number of clinical trials in Ukraine is caused by complex regulation, unreliable IP protection, and drug research taxation.

Lawsuits related to IP

- Certificate for trademark
- Patent for industrial design

Specifics of litigation in pharmaceutical industry

- Preliminary injunction measures are widely used
- Most cases are followed by forensic examination
- Competitors might get an access to registration dossier

Prohibition of issuing recommendations on drug registration, prohibition of import and drugs clearance etc.

Requires specific expertise in areas of IP, chemistry and biology.

Which is usually requested by the court during cases about violation of right on invention and utility model.



mln US dollars (pharmacy purchase price)






Leaders among joint-stock companies by revenue, mln hryvnias







Pharmacy sales structure divided by the holder of license, %









Pharmaceutics price changes divided by the holder of license, retail sales, %






SALES OF PHARMACEUTICAL PRODUCTS


Retail sales of pharmaceuticals by the region in 2016, bln hryvnias

TOP-3 distributors by the share of market in 2017, %




TOP-5 pharmacy networks by number of trade spots in 2017











TOP-10 exporting countries of pharmaceutical products in 2016, bln US dollars





TOP-10 importing countries of pharmaceutical products in 2016, bln US dollars




EXTERNAL ECONOMIC ACTIVITY

External trade of medicaments in Ukraine, 2017, mln US dollars




Pharmaceutical products trade flows in Ukraine,

mln US dollars




TOP-10 drug import directions in Ukraine in 2017, mln US dollars
